WRITTEN STATEMENT REQUIREMENT:

The Written Statement will be returned via e-mail (if provided) or regular mail to the requestor. Please allow 3-5 business days for receipt, research and issuance of the Written Statement. The Gregg County Tax Office cannot ensure that requests received the day of the Tax Sale can be completed prior to the end of the sale.

The certified Written Statement form must be submitted to the McCreary, Veselka, Bragg & Allen via email to bdameron@mvbalaw.com on or before the day of the sale in which the bidder intends to participate.

Sheriff's deed will NOT be issued without a valid Written Statement on file.
